MEMORANDUM OF UNDERSTANDING

GOVERNMENT ARTS AND COMMERCE COLLEGE KACHHAL - DIST-SURAT Village Kachhal, Taluka:- Mahuwa, District:- Surat - 394250. (Gujarat) the Second Party, and represented herein by **DR. HETAL SUSHILCHANDRA TANDEL - PRINCIPAL**, (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A. First Party is a Higher Educational Institution named:
 - (1) **NARAN LALA SCHOOL OF INDUSTRIAL MANAGEMENT & COMPUTER SCIENCES - NAVSARI**
- B. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C. The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Guest Lecture, Faculty Exchange, Education and Research etc.
- D. Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E. **GOVERNMENT ARTS AND COMMERCE COLLEGE KACHHAL - DIST-SURAT** -, the Second Party is engaged in fields of **EDUCATION**. - And related fields.
- F. **GOVERNMENT ARTS AND COMMERCE COLLEGE KACHHAL - DIST-SURAT** -, the Second Party is **DR. HETAL SUSHILCHANDRA TANDEL - PRINCIPAL**, Village Kachhal, Taluka:- Mahuwa, District:- Surat - 394250. (Gujarat) is promoted by Government of Gujarat, Education Department.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

1.1. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.

1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MoU

2.1 The budding graduates and post graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Skill Development Programs:** First Party may help to train the students of Second Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.3 **Guest Lectures:** First Party to extend the necessary support to deliver guest lecturers to the students of the Second Party on the technology trends and in house requirements.

2.4 **Joint Sponsored Research:** Both Party agrees to help identify and invite faculty members from the other institution to participate in research or development programmes.

2.5 **Exchange of Faculty:** Both Party agrees to encourage collaboration between faculty from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to, or take up fixed-term visiting assignments at, each other's institution as per convenience of both party.

2.7 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein

2.8 There is no financial commitment on the part of the Name of institution, mentioned in the MoU. If there

CLAUSE 3

INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4

VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **GOVERNMENT ARTS AND COMMERCE COLLEGE KACHHAL - DIST-SURAT** Village Kachhal, Taluka:- Mahuwa, District:- Surat - 394250. (Gujarat) Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **NARANLALA SCHOOL OF INDUSTRIAL MANAGEMENT & COMPUTER SCIENCE - NAVSARI, BHAGWATI SANKUL, SITARAM NAGAR, NR- ERU CHARRASTA, ERU, NAVSARI - 396450**

or

GOVERNMENT ARTS AND COMMERCE COLLEGE KACHHAL - DIST-SURAT Village Kachhal, Taluka:- Mahuwa, District:- Surat - 394250. (Gujarat), the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.


4.3 This MoU stand active till the signing authority exits on respective Designation.

CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES




